In compliance with the provisions of Section 82 of Spanish Securities Market Act 24/1988, dated 28 July, TÉCNICAS REUNIDAS, S.A. (the "**Company**") hereby reports the following

RELEVANT INFORMATION

- I. The Company's Board of Directors, in its meeting held on February 28th 2012, has prepared, regarding the year ended December 31st, 2011, the individual annual accounts of the Company, in accordance with current regulations and the National Chart of Accounts approved by the Royal Decree 1514/2007, and consolidated of its Financial Group, in accordance with the International Financial Reporting Standards. The net profit of the Company from the 2011 Financial Year, amounts to 77,165,747.8 €, while the net profit of the Financial Group amounts to 135,320,011 €.
- II. The Board has resolved to propose at the Ordinary General Shareholders Meeting of the Company, which will be appropriately convened, the following distribution of the Company's Earnings from the 2011 Financial Year:
 - a) 35,845,697 € under the concept of interim dividend (fixed gross amount of 0.667 € per share for all shares with a right to a dividend). The payment of this dividend took place on January 20th, 2012, having been fully paid up.
 - b) 36,974,274 € to payment of a complementary dividend (maximum amount to be distributed corresponding to a minimum gross amount of 0.688 € per share for all shares of the Company with a right to a dividend, according to shareholder composition at February 28th, 2012).
 - Therefore, if the proposed distribution is approved by the Ordinary General Shareholders Meeting of the Company, the amount of the interim dividend plus the complementary dividend will be $72,819,971 \in$, amount that exceeds 55% of the net profit of the Financial Group.
 - c) The remaining result will go to retained earnings.
- III. All applicable taxes payable will be withheld on account from the amounts to be distributed as a complementary dividend. If the proposal is approved by the General Shareholders Meeting, the resulting net amount will be paid during the first two weeks of July 2012.
