RELEVANT FACT

The Board of Directors of the Company held on June 29, 2017 has approved the distribution of an interim dividend corresponding to the 2017 financial results of 0.1440 euros per share, executing at its liquidation the applicable withholdings in accordance with the relevant tax regulations

The execution of the dividend payment is scheduled on July 12, 2017.

The last day of trading of the shares with a right to perceive the abovementioned dividend will be July 7, 2017, trading without such right as of July 10, 2017.

Since the Company’s shares are represented by means of book entries, the dividend will be paid in accordance with the regulations in force applicable to the depository entities, using the mechanisms that IBERCLEAR makes available to such entities, being the designated payment agent BANCO BILBAO VIZCAYA ARGENTARIA, S.A.

The Company will also notify the payment of the abovementioned supplementary dividend by means of a press release.
