SELECT US EQUITY PORTFOLIO NOW OPEN TO NEW INVESTORS

The board of directors of ACMBernstein SICAV (the “**Board**”), after consultation with the Investment Manager, AllianceBernstein L.P., has determined that it is suitable to re-open ACMBernstein SICAV—Select US Equity Portfolio (the “**Fund**”) to new investors.

The Fund was soft-closed to new investors in September 2014. Since that time, the Board and the Investment Manager have monitored the overall capacity and, given the current utilization coupled with the current market environment, have confirmed additional capacity exists.

As a result, new investors will be able to buy shares or exchange for shares of the Fund, effective immediately.
