Agencija za trg vrednostnih papirjev je prejela prijave več oseb, ki so preko telefona prejele ponudbo za nakup vrednostnih papirjev s strani družbe **Strategic Capital Partners Portfolio Management AG** (www.strategiccapiatal.ch), s sedežem v Zürich, Švica.

Družba **Strategic Capital Partners Portfolio Management AG** nima dovoljenja Agencije za trg vrednostnih papirjev za opravljanje storitev v zvezi z vrednostnimi papirji v Republiki Sloveniji, prav tako Agencija do dneva objave tega opozorila ni prejela zahteve za izdajo dovoljenja za ustanovitev podružnice navedene družbe.

Na podlagi poizvedbe pri švicarskemu nadzornemu organu SFBC – Swiss Federal Banking Commission in SWX Swiss Exchange je bilo ugotovljeno, da omenjena družba tudi v Švici ni pooblaščenca za opravljanje finančnih poslov.

Seznam družb, ki izpolnjujejo pogoje za opravljanje storitev povezanih z vrednostnimi papirji na območju Republike Slovenije, je objavljen na spletni strani Agencije www.atvp.si.

Agencija za trg vrednostnih papirjev investitorjem odsvetuje sklepanje poslov z družbo **Strategic Capital Partners Portfolio Management AG**, v primeru prejema njihove ponudbe pa naj ravnajo zelo previdno in upoštevajo vsebino tega javnega opozorila.

against Strategic Capital Partners Portfolio Management AG

Slovene Securities Market Agency is warning investors about activities of the company **Strategic Capital Partners Portfolio Management AG**, on the territory of Republic of Slovenia.

The Slovene Securities Market Agency has received an inquiry from several Slovene persons, who by telephone have been offered shares by a firm **Strategic Capital Partners Portfolio Management AG** (www.strategiccapiatal.ch), which has its head office in Zürich, Swiss.

Strategic Capital Partners Portfolio Management AG has not obtained the Agency's authorization according to Securities Market Act to carry out services in the securities field in Slovenia and by the date of this warning the Agency has not received any documentation proving that the authorization is sought in order to acquire that authorization.

According to the information that the Slovene Securities Market Agency has obtained, the SFBC – Swiss Federal Banking Commission, a Swiss financial services authority, and SWX Swiss Exchange, have not authorized the **Strategic Capital Partners Portfolio Management AG** company.

The Agency strongly urges investors considering dealing with **Strategic Capital Partners Portfolio Management AG** to exercise the greatest possible caution before proceeding, bearing in mind the contents of this public notice.
