abertis, (through its fully owned subsidiary Abertis Tower, S.A.), Telefónica and Yoigo, have completed the first stage of the agreement for the restructuring and rationalization of mobile passive infrastructures from Telefonica and Yoigo, after having obtained the authorization from CNMC. This stage implies the acquisition 1,741 mobile infrastructures for an amount of 171 million Euro and it is part of the agreement announced in Relevant Fact number 191525 dated 1 August 2013.

After this transaction, equipment owned by Telefonica and Yoigo will be co-hosted in these infrastructures. Both operators will be clients of this set of towers in the next years, and said towers will be available to any operator that may be interested.

The acquisition of this set of towers will consolidate the Group as a key player in the rationalization of the use of fixed and mobile telecom infrastructure in Spain. Furthermore, this transaction will allow the development of new business opportunities in the context of sharing the necessary infrastructure associated with the fourth generation of mobile telephony.
