

Investoradvarsel (klone av foretak med tillatelse)

Finanstilsynet advarer mot investeringstilbud markedsført av et selskap som gir seg ut for å være BNY Mellon Wealth Management (klone av foretak med tillatelse).

Finanstilsynet har mottatt opplysninger om at et selskap som gir seg ut for å være BNY Mellon Wealth Management og hevder å holde til i USA, har kontaktet norske investorer og tilbudt investeringstjenester uten tillatelse. Dette selskapet benytter navnet til et verdipapirforetak som driver grensekryssende virksomhet inn i Norge.

Finanstilsynet presiserer at foretaket som utgir seg for å være BNY Mellon Wealth Management ikke har noen forbindelse med det legitime foretaket BNY Mellon Wealth Managementshovedkontor i USA, eller noen av selskapene i dette konsernet.

Finanstilsynet oppfordrer investorer til å forsikre seg om at de, ved investeringer gjennom BNY Mellon Wealth Management, er i kontakt med det rette foretaket.

Investor warning (clone of authorised firm)

It has come to Finanstilsynet (The Financial Supervisory Authority of Norway) attention that a firm, calling itself BNY Mellon Wealth Management (purporting to be based in the USA.) has been operating as an investment firm in Norway in the absence of an appropriate authorisation. This unauthorised firm has cloned the name of a legitimate BNY Mellon business, BNY Mellon Wealth Management, that is based in in the USA.

It should be noted that there is no connection whatsoever between the legitimate BNY Mellon Wealth Management business in the USA (or any other BNY Mellon entity) and the unauthorised BNY Mellon Wealth Management entity that is operating in Norway.

Finanstilsynet wishes to make it clear to investors that they have to be careful when dealing with any entity calling itself BNY Mellon Wealth Management and take steps to make sure that they are dealing with the legitimate investment firm that has notified cross border activity into Norway.

BNY MELLON

BNY Mellon would like to clarify that the company “BNY Mellon Wealth Management” included in the recently released list is not part of BNY Mellon. This unauthorized firm has cloned the name of a legitimate BNY Mellon business, BNY Mellon Wealth Management, that is based in the U.S.A. and is using a reference to the legitimate website of BNY Mellon Wealth Management.

This has been acknowledged by Finanstilsynet (The Financial Supervisory Authority of Norway) and regulators in Ireland and Sweden that a firm, calling itself BNY Mellon Wealth Management has been operating as an investment firm in the absence of an appropriate authorization in order to solicit business from individuals in those countries.

It should be noted that there is no connection whatsoever between the legitimate BNY Mellon Wealth Management business in the U.S.A. (or any other BNY Mellon entity) and the unauthorized BNY Mellon Wealth Management entity that is operating in Norway.
