



PROSEGUR CASH, S.A.

NOTICE OF RELEVANT EVENT

In Madrid, on 7 March de 2018

The Board of Directors of PROSEGUR CASH, S.A. (“**PROSEGUR CASH**” or the “**Company**”), in its meeting held on 18th December 2017, approved the distribution of an ordinary interim dividend in a gross amount of 0.0716 euros per share, which implies a total maximum dividend amounting to 107,400,000 euros, payable in four instalments.

The Company communicates that the second instalment of said dividend, corresponding to 20% of the total, amounting to 0.0143200 gross euros per share (equivalent to 0.0115992 net euros per share), will be paid to the shareholders on 14th March 2018. Dividend ex-date is 12th March 2018.

Payments will be made effective through the member entities of Sociedad de Gestión de los Sistemas de Registro, Compensación y Liquidación de Valores, S.A. (IBERCLEAR). Withholdings taxes will be deducted in accordance with applicable law, from the gross amounts paid. Should the Company’s share capital and/or number of shares in which it is divided be modified, the gross amount payable per share at the relevant date will be adjusted accordingly.
