Pursuant to article 17 of the Regulation (UE) no. 596/2014 on Market Abuse, to article 228 of the Royal Legislative-Decree 4/2015, dated 23 October, approving the consolidated version of the Securities Market Act and to Section Four of Regulation 1/2017, dated 26 April, of the National Stock Exchange Committee, on liquidity agreements, regarding the liquidity agreement executed on 3 July 2017 with JB Capital Markets, S.V., S.A.U., which entered into force on 11 July 2017 and was resumed on 12 March 2018 after being suspended on 20 November 2017, Global Dominion Access, S.A.
