With effect from 2 January, 2013 the current Investment Manager of the Fund, The Dreyfus Corporation ("Dreyfus"), will be replaced as Investment Manager by Mellon Capital Management Corporation ("MCM").

This change follows a group business restructuring, as a result of which Dreyfus will focus on US\$-denominated investments. MCM currently manages over \$200bn in index tracking strategies.

The Fund's objectives and policies will not change as a result of this appointment and there are no other changes being made in relation to this Fund. Shareholder approval of the change is not required and you need take no action.

We will issue a revised Supplement for the Fund on 2 January 2013 to reflect this change. The appointment of MCM is subject to the approval of the Central Bank of Ireland.
