You currently hold shares in **LAZARD GLOBAL GREEN BOND OPPORTUNITIES Sub-Fund LAZARD FUNDS UCI** (hereinafter « the Sub-Fund »), and we are thanking you for that.

We kindly ask you to find below the information relating to the changes that will take place in your Sub-Fund on **04/25/2023**.

I. What changes will occur in your Sub-Fund?

Lazard Frères Gestion, delegated financial manager of the UCI, in agreement with your Board of Directors, has decided to appoint CPA, Ernst & Young (hereinafter “EY”) to obtain the SRI (Socially Responsible Investment) label for LAZARD GLOBAL GREEN BOND OPPORTUNITIES Sub-Fund of Lazard Funds UCI.

This approach is in line with its policy of taking environmental, social and governance (ESG) criteria into account.

The Sub-Fund was audited by EY on March 7th, 2023 and received the SRI label on March 13th, 2023.

Obtaining this label led us to integrate SRI criteria into direct held bonds’ selection.

This does not change LAZARD GLOBAL GREEN BOND OPPORTUNITIES’s asset allocation management central process, nor its risk/return profile.

II. When will these operations take place?

The changes are not subject to AMF' approval (French financial markets authority) and they will take effect on **April 25th, 2023**.

I. What is the impact of these changes on the risk/return profile of your investment?
