### Notification of closure and termination of the Fund

27 July 2020

Dear Shareholder,

We are writing to notify you of the decision of the Board of Directors of the Company (the “**Board**”) to close and terminate the Fund in accordance with the powers provided to the Board in the Company’s Constitution. The Investment Manager has been instructed to commence the realisation of all investments in the portfolio.

Accordingly, with effect from 31 August 2020 (the “**Effective Date**”) all Shares in the Fund which have not been previously redeemed will be compulsorily redeemed at the Net Asset Value per Share. Up until the Effective Date, Shareholders can redeem Shares in accordance with the normal redemption procedures outlined in the Prospectus on any Dealing Day.

The Directors further advise that, with effect from the date of this letter, the Fund will be closed to all new subscriptions and the Company will seek to revoke the Fund’s approval with the Central Bank of Ireland in due course.

As an alternative to redemption, Shareholders may want to consider switching their existing holdings in the Fund to any one of the Company’s other available sub-funds, subject to complying with the provisions set out under the heading *Exchange of Shares* in the Prospectus. The Directors and the Investment Manager agree to waive any Exchange Charge applicable to an exchange of Shares from the Fund. Notwithstanding the closure of the Fund the Company continues to have a sub-fund trading principally in European equity and equity related securities, the TT European Opportunities Long/Short Fund, a UCITS hedge fund managed by Dean Smith investing in a diversified portfolio of both long and synthetic short positions with the objective of achieving absolute returns.
