This third supplement (the “**Supplement**”) to the base prospectus dated 18 April 2017 (the “**Base Prospectus**”) comprises a supplement to the Base Prospectus for the purposes of Directive 2003/71/EC, as amended (the “**Prospectus Directive**”), which together with the first supplement to the Base Prospectus dated 6 June 2017 (the “**First Supplement**”) and the second supplement dated 10 August 2017 (the “**Second Supplement**”), and the Base prospectus, comprise a base prospectus for the purposes of Article 16 of the Prospectus Directive.

Terms defined in the Base Prospectus (as supplemented by First Supplement, Second Supplement, and this Supplement) have the same meaning when used in the Supplement. The Supplement is supplemental to, and should be read in conjunction with, the Base Prospectus (as supplemented by the First Supplement, Second Supplement and this Supplement) issued by BBVA Global Markets B.V. (the “**Issuer**”).

Each of the Issuer and Banco Bilbao Vizcaya Argentaria, S.A. (the “**Guarantor**”) accepts responsibility for the information contained in this Supplement. To the best of the knowledge of each of the Issuer and the Guarantor (which have taken all reasonable care to ensure that such is the case) the information contained in this Supplement is in accordance with the facts and does not omit anything likely to affect the import of such information.

This Supplement has been approved by the Comisión Nacional del Mercado de Valores (the “**CNMV**”), as competent authority under the Prospectus Directive. The CNMV only approves this Supplement as meeting the requirements imposed under Spanish and EU law pursuant to the Prospectus Directive.

PURPOSE OF THE SUPPLEMENT

The purpose of this Supplement is to (i) incorporate by reference the Condensed Interim Consolidated Financial Statements of the Guarantor (as defined below), (ii) incorporate by reference the Issuer’s Interim Financial Statements (as defined below), (iii) confirm that there has been no significant change in the financial and trading position of the Guarantor and its consolidated subsidiaries (the “**Group**”) since the date of the Condensed Interim Consolidated Financial Statements, (iv) confirm that there has been no significant change in the financial and trading position of the Issuer since the date of the Issuer’s Interim Financial Statements and (v) update the Summary of the Base Prospectus.
