NOTICE OF RELEVANT EVENT

In Madrid, on 30th June 2017

Further to the relevant events published on 8 May and 8 June 2017 (with register numbers 251751 and 253056 respectively), in connection with the subscription of a Liquidity Contract and subsequent commencement of transactions, PROSEGUR CASH, S.A. (“**PROSEGUR CASH**”) communicates details of transactions carried out during the first quarter of validity of said contract (from 9 June to 30 June 2017, both inclusive), in this case coinciding with the second quarter of the current year, as stated in the Norma Cuarta apartado 2 b) of Circular 3/2007, of 19 December, of the Spanish National Securities Market Regulator (*Comisión Nacional del Mercado de Valores*) on Liquidity Contracts, for the purposes of their acceptance as a market practice.
