The Financial Services and Markets Authority (FSMA) warns the public against the activities of J McKenzie / McKenzie International Investments, a company that offers investment services.

J McKenzie / McKenzie International Investments is **not allowed** to offer investment services in or from Belgium.

According to information available to the FSMA, moreover, this may be a case of fraudulent activity, and more particularly of 'boiler room' fraud. More information about this form of fraud is available in the **general warning**
