We refer to the above heading and to the notification of 12th September 2001 relating to the suspension of the calculation of the Net Asset Value on a number of the Aberdeen Global SICAV Sub-Funds. We have today reviewed the situation and have lifted the suspension on the Aberdeen Global-Asia Pacific Fund as the Asian Markets have today opened for trading.
