Investoradvarsel

Kredittilsynet advarer mot investeringstilbud markedsført av Quality Investments B V NUF

Kredittilsynet har mottatt opplysninger om at **Quality Investments B V NUF** (adresse: Storgata 4, 8004 Bodø, Norge) har kontaktet norske investorer og tilbudt investeringstjenester. Henvendelser har også blitt gjort i navnet til det spanske selskapet Quality Capital Management S.L. (adresse: Urb. Lomas de Sierra Blanca, C.C. LE VILLAGE Oficinas 9-11, 29602 Marbella, Malaga, Spain) og under navnet Quality Investments Norge AS. Kredittilsynet gjør oppmerksom på at Quality Investments Norge AS ikke er registrert i Brønnøysundregistrene.

Kredittilsynet gjør oppmerksom på at verken Quality Investments B V NUF, Quality Capital Management S.L. eller Quality Investments Norge AS har godkjenning til å drive investeringstjenester i Norge, og har derfor ikke nødvendig godkjenning i henhold til norsk lov. Dette innebærer at Kredittilsynet ikke har tilsynskontroll over selskapene eller har godkjent de tjenestene som tilbys. Kredittilsynet anbefaler derfor investorer å ikke inngå avtaler etter henvendelser fra ovennevnte.

Kredittilsynets register inneholder informasjon om alle foretak som har tillatelse til å tilby investeringstjenester i Norge. På nettsidene til Kredittilsynet finnes også en liste (ikke fullstendig) over aktører i markedet som opererer uten tillatelse.

Investor warning

Kredittilsynet (The Financial Supervisory Authority of Norway) warns against investment offers promoted by Quality Investments B V NUF

Kredittilsynet has been informed that **Quality Investments B V NUF** (adresse: Storgata 4, 8004 Bodø, Norge) has approached Norwegian investors offering investment services. Approaches has also been done in the name of the Spanish firm Quality Capital Management S.L. (address: Urb. Lomas de Sierra Blanca, C.C. LE VILLAGE Oficinas 9-11, 29602 Marbella, Malaga, Spain) and Quality Investments Norge AS. Kredittilsynet calls attention to the fact that Quality Investments Norge AS is not registered in The Register of Business Enterprises.

Kredittilsynet wishes to make it clear that neither Quality Investments B V NUF, Quality Capital Management S.L. or Quality Investments Norge AS are authorised to provide investment services in Norway, and therefore lacks the licence required under Norwegian law. The company is consequently not subject to Kredittilsynet's supervisory oversight, nor has Kredittilsynet approved the services offered by the company. Kredittilsynet therefore recommends investors not to enter into agreements after approaches as mentioned above.

Kredittilsynet's registry gives details of all companies authorised to offer investment services in Norway. A list (not complete) of companies operating in the market without a licence can be found on Kredittilsynet's website.
