

## **Advarsel mod Akeman Capital (også kaldt Akeman Allan Capital)**

### **ADVARSEL**

Finanstilsynet har fået henledt opmærksomheden på, at et selskab ved navn **Akeman Capital (også kaldt Akeman Allan Capital)** uopfordret har kontaktet danske borgere. På selskabets hjemmeside ([www.akemancapital.com](http://www.akemancapital.com) samt [www.akemanallan.com](http://www.akemanallan.com)) er det angivet, at selskabet har adressen: Calle Camilo Jose Cela 1, L-5; Modulo 102; 41018 Sevilla; Spanien.

Selskabet har efter det til Finanstilsynet oplyste tilbudt formidling af finansielle tjenesteydelser.

**Akeman Capital (også kaldt Akeman Allan Capital)** har ikke tilladelse til i Danmark at tilbyde tjenesteydelser omfattet af lov om finansiel virksomhed og er ikke under tilsyn hos Finanstilsynet.

Selskabet er ikke blevet notificeret over for Danmark fra den spanske tilsynsmyndighed, CNMV.

The Danish Financial Supervisory Authority has been informed that a company named **Akeman Capital (also named Akeman Allan Capital)** unsolicited has contacted Danish citizens. At the company's homepage ([www.akemancapital.com](http://www.akemancapital.com)) it is stated that the company has the address: Calle Camilo Jose Cela 1, L-5; Modulo 102; 41018 Sevilla; Spain.

According to information given to The Danish Financial Supervisory Authority, the company has offered to carry out financial services.

**Akeman Capital (also named Akeman Allan Capital)** does not have authorization from the Danish Financial Supervisory Authority in accordance with the Financial Business Act to carry out such services in Denmark.

The company has not been notified in Denmark from the Spanish Financial Supervisory Authority (the CNMV).
