Pursuant to article 228 of the restated text of the Securities Market Law, we hereby inform you of the following **SIGNIFICANT EVENT**:

Effective from July 9, 2017, the liquidity agreement entered into on May 24, 2017 between Pharma Mar, S.A. and MEDIACIÓN BURSÁTIL, SOCIEDAD DE VALORES, S.A. has terminated. Below are detailed the operations carried out under the aforementioned liquidity agreement since the date of its entry into force (29/05//2017 to 09/07/2017). The balance of the cash account at the termination of this agreement amounts to EUR 1,303,821.15, while the balance of the securities account amounts to 647,341 shares, of which 339,537 shares will be contributed as initial amount of shares to the new Liquidity Agreement referred to in the paragraph below and the rest (307,804 shares) will be allocated to the treasury stock of the Company.

In addition, the Company intends to enter today into a new Liquidity Agreement with MEDIACIÓN BURSÁTIL, SOCIEDAD DE VALORES, S.A., subject to the provisions of Circular 1/2017, of 26 April, of the National Securities Market Commission, on liquidity agreements, entering into this Agreement in force on July 11.
