Banco Bilbao Vizcaya Argentaria, S.A. (BBVA), de conformidad con lo establecido en la legislación del Mercado de Valores, comunica lo siguiente:

INFORMACIÓN RELEVANTE

BBVA informa sobre los anuncios realizados hoy por la Autoridad Bancaria Europea (EBA en sus siglas en inglés) y el Supervisor Nacional competente en relación con el ejercicio de capital, con el siguiente resultado:

El ejercicio de capital propuesto por la EBA y acordado por el Consejo el 26 de octubre de 2011 requiere a los bancos un fortalecimiento de sus posiciones de capital exigiéndoles un requerimiento extra de capital de carácter temporal para la cobertura de las exposiciones a deuda soberana que refleje los precios de mercado actuales. Además, les exige un requerimiento extra de capital de modo que el ratio core Tier 1 (CT1 en sus siglas en inglés) alcance un nivel de 9% para finales de junio de 2012. El requerimiento extra de capital final identificado se basa en datos de septiembre de 2011 y tiene una naturaleza excepcional y temporal. El importe del requerimiento extra de capital por la exposición a deuda soberana no será revisado.

Tras la finalización del ejercicio de capital llevado a cabo por la Autoridad Bancaria Europea, en estrecha cooperación con la autoridad nacional competente, y realizado a 71 bancos en toda Europa, el ejercicio ha determinado que para BBVA:

La cuantificación definitiva del requerimiento extra de capital a septiembre de 2011, en línea con la estimación de BBVA tras la publicación del dato preliminar, es de 6.329 millones de euros que deben abordarse para finales de junio de 2012. De esta cuantía, 2.313 millones de euros corresponden al requerimiento de capital por la exposición a deuda soberana.

BBVA garantiza que para finales de junio de 2012 alcanzará el 9% de CT1 y, para ello, presentará un plan al Supervisor Nacional competente. En este plan, BBVA presentará una propuesta de acciones para cumplir el objetivo requerido del 9% dejando en consecuencia el requerimiento extra de capital a cero para junio de 2012. El plan - que deberá ser presentado para el 20 de enero de 2012- se examinará con las autoridades nacionales competentes, en consulta con el correspondiente Colegio de supervisores y la EBA.

BBVA ya está adoptando medidas dirigidas a cubrir el requerimiento extra de capital indicado por la EBA, entre las que destaca el reciente canje de preferentes por bonos convertibles anunciado el pasado 22 de noviembre. Junto a esta acción, BBVA está en disposición de cumplir con los requerimientos establecidos por la EBA mediante generación orgánica de capital y otras medidas de gestión de balance. Como ya se señaló en el hecho relevante del 27 de octubre de 2011, BBVA descarta, en todo caso, la percepción de ayudas públicas.
