Dear Shareholder,

The Company would like to inform you of our decision to close the Share Classes in the sub-funds of the Company (as listed in Appendix A, each a “**Fund**”, collectively, the “**Funds**”) on 15 December, 2022 (the “**Termination Date**”) pursuant to the Company’s Articles of Association.

Rationale

The Directors have determined to close the Share Classes following a review of their economic viability, taking into account factors such as the net asset value of the Share Classes. Consequently, the Share Classes will be closed to further subscriptions with effect from 3 November, 2022.

Until the Termination Date, you may redeem or exchange your current holding in the Share Class(es) for another share class(es) offered by the Company in accordance with, and subject to, the procedures described in the Prospectus, without any charge being imposed by the Fund.

Before investing in another share class of the Company, please ensure that you have read and understood the investment policies and fees applicable to the relevant sub-fund as described in the Prospectus and the Key Investor Information Document (“**KIID**”). Copies of the Prospectus are available free of charge on request from the Administrator or the Company’s appointed representative in that country and the KIID is available at www.pimco.com.

No redemption requests will be accepted after the Termination Date. Should you remain as a shareholder in the Share Class as at the Termination Date, your holdings will be redeemed in cash at the net asset value as of the Termination Date.


