

RELEVANT FACT

This notification follows on from the relevant fact of 24 September 2013 (no 193107), in relation to the issue of 13,250,262 new ordinary shares in International Consolidated Airlines Group, S.A. ("IAG") in order to effect the conversion requests received from holders of the British Airways Plc £350,000,000 5.80 per cent. convertible bonds due 2014.

In connection with this, IAG announces that the deed recording the issue of the above mentioned 13,250,262 new ordinary shares in IAG has been registered at the Madrid Commercial Registry.
