NOTICE TO THE SHAREHOLDERS

The Board of Directors of the Gartmore SICAV (the "SICAV") has decided to amend the prospectus of the SICAV by deletion of the provision pursuant to which any expenses of the SICAV, other than the annual management charge payable to the Investment Manager and the service fee payable to the Principal Distributor, exceeding the annual cap of 0.25% per annum of the Net Asset Value of the SICAV will be paid by the promotor of the SICAV, the Investment Manager or the Principal Distributor.

The above amendment shall come into effect on 7<sup>th</sup> December 2001.

The Board of Directors of the SICAV has decided furthermore to clarify the investment objectives of all Funds of the SICAV. The revised wording does not affect the investment portfolios or policies of the Funds and will not of itself result in a change to the assets held in the Funds, in the sense that each Fund shall focus on investments in companies having their registered office in a specific region or country, rather than on investments in companies listed on stock exchanges of the relevant region or country.

As a consequence of such amendment, the existing Prospectus of the SICAV, dated March 2001 shall be replaced by an updated Prospectus, dated October 2001, available at the registered office of the SICAV.

Como consecuencia de dicha modificación, el Folleto Informativo vigente de la SICAV, de marzo de 2001, será remplazado por una versión actualizada del mismo, de octubre del 2001, disponible en las oficinas de la SICAV.
