“Konzept More”: evidence indicates no prospectus published

The Financial Supervisory Authority (BaFin) has grounds to suspect that Berformance Group AG, Suxsess One GmbH and Block4you s.r.o. are publicly offering the investment product “Konzept More” in Germany without the required prospectus. The product offers combined lease and sub-lease agreements for crypto ATMs and mining hardware.

There is no evidence to suggest exemption from the prospectus requirement

Background information: Capital investments may be offered to the public in Germany only if a prospectus has been published. This prospectus must be approved by [BaFin](#) prior to publication. [BaFin](#) checks whether the minimum information required by law is included in the prospectus and whether its content is understandable, coherent and consistent. [BaFin](#) is not responsible for checking whether the information contained in the prospectus is correct, for assessing the integrity of the issuer or for monitoring the product in question. Issuers of capital investments must ensure that this is clearly indicated in their prospectuses. The issuers are liable for the accuracy of the information provided in the prospectus.

[BaFin](#) advises consumers to invest funds in investment products solely on the basis of all required information.

You can check whether an approved prospectus for an offer of securities to the public has been filed with [BaFin](#) by consulting the [Prospectuses filed database](#) on the [BaFin](#) website.

In accordance with section 4 (4) of the German Act Establishing the Federal Financial Supervisory Authority (Finanzdienstleistungsaufsichtsgesetz – [FinDAG](#)), [BaFin](#) performs its functions and exercises its powers exclusively in the public interest.
