Buy-back programmes, stabilisation and treasury stock

Pursuant to article 17 of the Regulation (UE) no. 596/2014 on Market Abuse, to article 228 of Law 6/2023 dated March 17 on the Securities Markets and Investment Services, and to other applicable regulations –and as a continuation of the communication published on December 20, 2023 (registration number 25901) relating to the announcement of a share buy-back programme– Vidrala, S.A. ('Vidrala' or the 'Company') hereby reports the transactions carried out over its own shares between 16 and 20 September 2024 (both inclusive), under the share buy-back programme approved by the Board of Directors of the Company in accordance with the authorisation granted by the General Shareholders' Meeting.

Detailed information of the transactions carried-out within the referred period is attached as Annex.

As a result of the foregoing, the Company communicates the completion of the repurchase program prior to its deadline –which was set for December 20, 2024– having reached the maximum number of shares to be acquired under the share buy-back programme. In total, 330,000 shares have been acquired for a cash amount of EUR 31.1 million, equivalent to an average price of EUR 94.24 per share.

The acquisition of the own shares under the share buy-back programme has been periodically communicated, in accordance with articles 2.2 and 2.3 of Delegated Regulation (EU) 2016/1052.

The purpose of the programme is to reduce the share capital of the Company by the redemption of own shares, with the aim of contributing to the shareholders' remuneration policy through the increase in earnings per share. Once the corresponding corporate

resolutions have been adopted, the Company will inform about the details and execution of the capital reduction.
