The acquisition of 50,000 shares of the Company described in the previous paragraph, has taken place independently to the Buy Back Program through a block trade. To date, the Company has not taken any specific decision on the destination of the shares acquired in the referred transaction.

Following the acquisition of the above-mentioned block of shares and the modification of the Buy-back Programme published by the Company through a communication of "other relevant information" (No. 576) on the 28th of February 2020, the maximum amount of shares targeted by the Buy Back Program is set at 4,718,811, without deducting the shares already acquired under the Buy-back Programme since its establishment.

If during the term of the Buy-back Programme, the treasury stock reaches 9.99% of the subscribed voting capital (equal to 4,675,973 shares), the Buy-back Programme shall be automatically suspended until the number of Aedas' treasury stock is reduced below the aforementioned percentage of the share capital and by a percentage equal to the number of shares acquired in execution of the Buy-back Programme up to that time.
