

## JURY'S DECISION ON THE 2021 ANTONIO MORENO ESPEJO JOURNALISM AWARD

The Jury of the 2021 Antonio Moreno Espejo Journalism Award has decided to give the award in its fifth edition to the following article: “La amenaza de la mala reputación” (The threat of bad reputation) by Víctor Martínez published in the business magazine *Actualidad Económica* in July 2021.

The Jury has based its decision on the quality of the article, the relevance of the topic chosen, and the comprehensive analysis carried out on the importance of ethics in good corporate governance in companies, and in general, in the economy. In addition, the Jury considers that the award-winning article reflects the fact that these matters are still under financial and economic discussion throughout the world, as well as their impact on companies’ reputation and results.

The article also contains a wide range of opinions and reflections on the matter and highlights the current consensus on the value and principles that the Prize seeks to safeguard.

131 articles published in 38 different media were entered into or selected on a preliminary basis for this year’s call.

The CNMV created this award in memory of Antonio Moreno Espejo, who was a member of the institution's staff from its inception in the late eighties until his untimely death, when he was the director of the Institution Authorisation and Registration Department, in January 2017. The award carries a cash price of 15,000 euros.
