Likewise, it is reported that CELLNEX has resolved to terminate the Buy-back Programme early, as the Company has reached the maximum number of shares to be acquired under said Programme.

In execution of the said Buy-back Programme, 126,000 shares have been acquired equivalent to 0.0259% of the Company's share capital, for an effective amount of 6,508,886.7 euros, which is equivalent to an average price of 51,66 euros per share.

The acquisition of own shares under the Buy-back Programme has been carried out in accordance with the terms and conditions set forth in Delegated Regulation 2016/1052.
