In relation to the notice of "Other Relevant Information" of 6 May 2021 (Registry No.: 9276) relating to the buy-back programme of own shares approved by the Board of Directors of PRISA in accordance with the authorisation granted by the General Shareholders' Meeting held on 25 April 2018 (the "Buy-Back Programme") and pursuant to the provisions of section 227 of the restated text of the Securities Market Act (*Ley del Mercado de Valores*), approved by Royal Legislative Decree 4/2015, of 23 October, and related provisions, and in accordance with articles 2.2 and 2.3 of Commission Delegated Regulation (EU) 2016/1052 of 8 March 2016 supplementing Regulation (EU) No 596/2014 of the European Parliament and of the Council with regard to regulatory technical standards for the conditions applicable to buy-back programmes and stabilisation measures, the Company hereby informs that between 10 and 15 June 2021 it has carried out the following transactions over its own shares under the Buy-back Programme:

Besides, the Company communicates that due to the abovementioned acquisitions, the Company has acquired a sufficient number of shares to fulfil the purpose to comply with the obligations derived from the Medium Term Incentive Plan for the period 2018/2020 addressed to the Managing Director, Senior Managers and other Managers of PRISA and, as the case may be, of the dependent companies, which was approved by the Ordinary General Shareholders' Meeting on 25 April 2018, since the final settlement of said Medium-Term Incentive Plan has yielded a lower number of shares to distribute than initially provided. Therefore, it has decided to end the Buyback Programme prior to its initial deadline (i.e., 30 September 2021).

The final number of shares acquired within the Buy-Back Programme has amounted to 612,594 representing approximately 0.0864% of the Company's share capital as of the date of this communication. The monetary amount invested in such shares has amounted to 547,840.54 euros (including paid brokerage fees and commissions). All this has been achieved through the operations communicated to the market through the Other Relevant Information published on 13, 20 and 27 May and 3 and 10 June, with registration numbers 9429, 9532, 9684, 9803 and 9927, respectively.

Likewise, the Company informs of the reactivation of the liquidity agreement for the management of its treasury shares, entered into between the Company and JB Capital Markets, Sociedad de Valores, S.A.U., which was communicated to the market on 26 July 2019 by means of significant event, with registration number 280677, that had been suspended due to the Buy-Back Programme.
