Retirement of Coronavirus-related Additional Stress Analysis

The RMBS tranches placed or maintained on RWP could be upgraded following the retirement of coronavirus-related additional stress analysis scenario (see 'Fitch Retires UK and European RMBS Coronavirus Additional Stress Scenario Analysis, except for UK Non-Conforming' at www.fitchratings.com). Fitch expects to resolve the RWP by 23 January 2022.

The main reason for the retirement of the additional stresses is improved macroeconomic forecasts, the limited to no performance deterioration observed so far, and our expectation that the stress included in our representative pool foreclosure frequency and house price decline assumptions is sufficient to account for the remaining uncertainty related to the pandemic.

Out of the 121 tranches on RWP, 63 are from UK transactions, 53 from Spanish deals, four from Portuguese deals and one tranche is from a German transaction.

Best/Worst Case Rating Scenario

International scale credit ratings of Structured Finance transactions have a best-case rating upgrade scenario (defined as the 99th percentile of rating transitions, measured in a positive direction) of seven notches over a three-year rating horizon; and a worst-case rating downgrade scenario (defined as the 99th percentile of rating transitions, measured in a negative direction) of seven notches over three years. The complete span of best- and worst-case scenario credit ratings for all rating categories ranges from 'AAAsf' to 'Dsf'.
