The Board of Directors of the Company, at its meeting held on 23 March 2022, in view of the evolution of the Company's business up to that point, resolved to distribute an interim dividend on the profits of the current financial year, which ends on 31 March 2022, for a gross amount per share of EIGHTY-TWO CENTS (€0.82) to be distributed to the shares entitled to receive it according to the calendar set out below (the "Interim Dividend").

The distribution of the Interim Dividend is taking place under the aegis of the Shareholder Remuneration Policy approved by the Company on 21 July 2021, and the amount will be supplemented in accordance with that Policy following the appropriate approval of the annual accounts corresponding to the current financial year by the general meeting of shareholders.
