Further to the other relevant information notice published on 26 June 2024 (with registration number 29332), we hereby inform that on 5 August 2024 the public deed relating to the share capital reduction in the amount of 37,484,375.50 euros by reducing 0.50 euros the nominal value of the shares of the Company has been registered with the Commercial Registry of Bizkaia.

As a result, the share capital of the Company has been set at 578,009,070.21 euros, divided into 74,968,751 ordinary shares, with a nominal value of 7,71 euro each, which grant a total of 74,968,751 voting rights (one per share).

The share capital reduction was approved by the ordinary shareholders meeting of the Company held on 17 April 2024, under item Six of its agenda.
