SUPPLEMENTARY INFORMATION TO THE CALL NOTICE OF THE ANNUAL SHAREHOLDERS' MEETING OF AMADEUS IT GROUP, S.A.

Royal Decree 550/2020 of June 6, extends until June 21 the state of emergency declared by Royal Decree 463/2020, of March 14, 2020, declaring a state of emergency to manage the COVID-19 public health crisis, and will be in force on the days June 17 and June 18, 2020, the dates on which the Annual Shareholders' Meeting is scheduled to be held on first and second call, respectively. On these dates, the risk to public health derived from the pandemic that has given rise to the state of emergency, social distancing measures, restrictions on national and international geographic mobility, as well as restrictions on maximum seating capacities permitted in Phase II or Phase III in enclosed venues will remain in effect. Accordingly, it is entirely recommendable to hold the Annual Shareholders' Meeting without the physical presence of the shareholders.

In view of the above and in accordance with article 41 of RDL 8/2020 of March 17, 2020, on urgent and extraordinary measures to confront the economic and social impact of COVID-19 - as amended by section Fourteen of Final Provision One of RDL 11/2020, of March 31, 2020), as was indicated in the call notice published on May 13, 2020, the Annual Shareholders' Meeting will be held with the exclusively electronic attendance of the shareholders on the dates and at the times and with the agenda set out in the call notice, that is, foreseeably on June 18, 2020 on second call, at 11:00 a.m. In this respect, shareholders wishing to attend the Shareholders' Meeting by electronic means may do so by following the instructions issued in this regard in the call notice and on the Company's corporate website (www.corporate.amadeus.com), 2020 Shareholders' Meeting, in the "electronic attendance (electronic vote)" section. In any event, the Shareholders' Meeting will be broadcast live on the Company's corporate website (www.corporate.amadeus.com), 2020 Shareholders' Meeting, in the "Connection to the Shareholders' Meeting via streaming" section. The above notwithstanding, shareholders are reminded that they may exercise their proxy and voting rights by means of distance communication prior to the Shareholders' Meeting on the terms set out in the call notice and on the Company's corporate website (www.corporate.amadeus.com), 2020 Shareholders' Meeting, in the "Procedure for casting votes and granting representation through remote communication means" section.
