



TALGO, S.A. (“**Talgo**” or the “**Company**”) pursuant to the article 227 of the restated Spanish Securities Market Act (*Ley del Mercado de Valores*) approved by *Real Decreto Legislativo 4/2015, de 23 de octubre*, hereby discloses the following

RELEVANT INFORMATION

In connection with the regulatory announcement (*hecho relevante*) (no. 271608) published on 15 November 2018, regarding the set-up of a buy-back programme of own shares (the “**Buy-back Programme**”), the Company reports the temporary suspension of the Buy-back Programme having reached 9.99% of the share capital, including the shares acquired outside the Buy-back Programme. In this sense, as it was communicated to the market in the aforementioned announcement, the terms and conditions of the Buy-back Programme expressly provided for the automatic suspension of the Buy-back Programme in the event that the Company became owner at any time of 9.99% of the share capital of the Company until the corresponding capital reduction is executed.

For this end, as it has been communicated to the market through the corresponding notice of relevant information (No. 814), it has been agreed to execute the capital reduction through amortization of own shares agreed by the General Meeting. In this regard, the Company plans to resume the Buy-back Programme following the registration of the public deed relating to the reduction of capital in the Mercantile Registry, and subsequently to communicate it to the market by publishing the corresponding announcement of relevant information.

In addition, the Company hereby informs that, during the period between 2 and 10 of March 2020, both included, the Company has carried out the following transactions over its own shares under the Buy-back Programme:
