### RELEVANT INFORMATION

As a continuation of the relevant information number 14 published on February 11, 2020, the Company informs that, under the fifth program for the repurchase of treasury shares to be redeemed, during the period between March 1 and 9, 2021, has carried out the purchase of 140,000 treasury shares.

Currently, the Company holds 140,000 treasury shares (0.14 %).
