In addition to the above, the Company reports that, after the reported transaction, the Company has acquired a 9.45% of the maximum number of shares prescribed in the Repurchase Program (2,000,000 shares, representing approximately 0.44% of the Company's share capital). The shares have been acquired for a cash amount of EUR 339,430.09.
