Further to the inside information communications published today (number 582 and 583) regarding the sale of a block of up to approximately 12.12 million existing ordinary shares of **Fluidra, S.A.** (the “**Shares**” and the “**Company**”), BofA Securities Europe SA hereby announces that once the accelerated bookbuild process directed to qualified investors (the “**Placement**”) conducted by BofA Securities Europe SA and Joh. Berenberg, Gossler & Co. KG (the “**Joint Bookrunners**”) has been completed, the final terms of the placement have been determined. AZ Capital and STJ Advisors have acted as financial advisors to the seller (Piscine Luxembourg Holdings 1 S.à r.l.).

The number of Shares placed in the Placement amounts to 12,121,212 representing approximately 6.2% of the Company’s share capital. The Placement has amounted to a total of approximately €200,000,000, with the selling price being €16.50 per Share. The Company has repurchased 978,146 Shares in the Placement at the referred selling price per Share.

Further to the completion of the Placement, Piscine Luxembourg Holdings 1 S.à r.l. holds 63,028,788 ordinary shares of the Company, representing approximately 32.2% of its issued share capital.

Settlement of the transaction is expected to take place on 23 November 2020.
