Madrid, October 26, 2022

Reference is made to the inside information registered with the Spanish Securities Market Commission on July 28, 2022 (registration number 1553) relating to the share buy-back programme implemented by the Company pursuant to the authorization granted by the General Shareholders' Meeting held on May 6, 2022, under item tenth of the agenda (the "Buy-back Programme").

Pursuant to the provisions of the Regulation (EU) No. 596/2014, 16 April 2014, on Market Abuse and the Commission Delegated Regulation (EU) No. 2016/1052, 8 March 2016, supplementing the Regulation on Market Abuse, Repsol informs that between October 19 to 26, 2022 the Company has carried out the following transactions under the Buy-back Programme:

Repsol also informs that, after the last of the aforementioned acquisitions, the Company reached the maximum number of shares to be acquired under the Buy-back Programme ("MNS"), i.e. 50,000,000 shares (representing approximately 3.44% of Repsol's share capital prior to the execution of the capital reduction referred to below).

As a result of the foregoing, and in accordance with the terms of the Buy-back Program, the Company also informs that the purpose of the Buy-back Programme has been fulfilled and that, therefore, its completion occurs before the deadline of validity (December 31, 2022).

The acquisition of shares under the Buy-back Programme has been communicated on a regular basis, pursuant to the provisions of article 2.2 and 2.3 of the Commission Delegated Regulation (EU) No. 2016/1052.

Repsol also hereby informs that today the CEO, pursuant to the delegation granted in his favor by the Board of Directors of Repsol, has resolved to execute the capital reduction approved by the Board of Directors on July 27, 2022, pursuant to the resolution approved by the General Shareholders' Meeting 2022 under item eight of the agenda.

The share capital of Repsol has been reduced by 75,000,000 euros, through the redemption of 75,000,000 own shares with a par value of one euro each, representing approximately 5.16% of the share capital prior to the capital reduction. The share capital of the Company resulting from the reduction has been set at 1,377,396,053 euros, corresponding to 1,377,396,053 shares with a par value of one euro each.

As a result of the capital reduction, the following shares have been redeemed: (i) 50,000,000 own shares acquired under the Buy-back Programme; and (ii) 25,000,000 own shares included in the treasury shares as of July 27, 2022.

The purpose of the capital reduction is to redeem treasury shares, contributing to the Company's shareholder remuneration by increasing the profit per share. The reduction does not involve the return of contributions to the shareholders since the Company is the holder of the redeemed shares.

For the purposes of article 335 Spanish Companies Act, a reserve for redeemed share capital with a charge to free reserves (specifically, charged to the voluntary reserves account) will be set up for an amount equal to the nominal value of the redeemed shares, which it will be possible to use only in accordance with the same requirements in place for reducing share capital. Consequently, in accordance with article 335 c) Spanish Companies Act, creditors will not have the opposition right referred to in article 334 of the same Act in relation to the capital reduction.

The announcements of the capital reduction will be published in the Official Gazette of the Spanish Commercial Registry and in the corporate web page (www.repsol.com) in the next few days.

Thereafter, the public deed regarding the reduction of share capital and the amendment of the Bylaws will be granted and registered with the Commercial Registry of Madrid, and the Company will request the delisting of the 75,000,000 redeemed shares from the Madrid, Barcelona, Bilbao and Valencia Stock Exchanges, through the Stock Exchange Interconnection System (Continuous Market).
