## MFE-MEDIAFOREUROPE N.V.: ADJUSTMENT OF THE MEDIUM/LONG-TERM INCENTIVE AND LOYALTY PLAN FOR THE YEARS 2021-2023 AS A RESULT OF THE REVERSE STOCK SPLIT

As a result of the reverse stock split of the category "A" and "B" ordinary shares at a ratio of 5:1 which took effect on 23 October 2023 as communicated to the market on the same date (the "**Reverse Stock Split**"), today the Board of Directors took a series of decisions aimed at adjusting the economic terms and conditions of the "*Medium-Long-Term Incentive and Loyalty Plan for the years 2021, 2022 and 2023 for the Executive Bodies and Certain Executives of the MFE Group*", as approved by the Shareholders' Meeting held on 23 June 2021 (the "**Plan**"), adjusting both the number of shares underlying the rights granted under the Plan and the reference price of the rights themselves according to the Reverse-Split Ratio, all in accordance with the Plan regulations.

The information regarding the beneficiaries and the updated number of rights respectively allocated are given in the table attached to this press release.

The main terms and conditions of the Plan, established also with the objective of retaining human resources who are significant to the achievement of the group's strategic results, as well as the characteristics of the rights granted under the Plan, are described in the information document made available to the public at the company's registered office and on the company's website at <u>https://www.mfemediaforeurope.com</u>.
