In accordance with article 227 of Law 6/2023, of 17 March, on the Securities Markets and Investment Services (*Ley 6/2023*, *de 17 de marzo*, *de los Mercados de Valores y de los Servicios de Inversión*), and related provisions, is hereby reported the following:

## OTHER RELEVANT INFORMATION

In relation to the execution of the reduction of share capital by means of the redemption of treasury shares announced by means of a communication of relevant information dated 29 October 2024 (registration number 31,075), the deed of capital reduction (and consequent modification of the Bylaws) of Pharma Mar, S.A. in the amount of EUR 79,607.40 through the redemption of 132,679 shares of treasury stock of EUR 0.60 nominal value each, has been registered in the Madrid Commercial Registry.

The share capital resulting from this reduction has been set at EUR 10,933,336.80, divided into 18,222,228 shares of EUR 0.60 nominal value each.

The share capital reduction will take effect on 27 November 2024 (the "Effective Date"). On the Effective Date the shares redeemed will be delisted on the Madrid, Barcelona, Valencia and Bilbao Stock Exchanges, on which the stock is listed, through the Spanish Stock Exchange Interconnection System (Continuous Market).
