## **OTHER RELEVANT INFORMATION**

**First.** The Company's Board of Directors at its meeting held today, 28th of April 2019, has resolved to remove Mr. Jorge Gabiola as Director in the category of other external directors and also as non executive Chairman, and, with the prior report and proposal made to that effect by the Appointments and Remunerations Committee, has resolved the simultaneous appointment by co-option of Mr. Jorge Gabiola as Director in the category of independent directors.

Mr. Gabiola asummed the chairmanship in October 2018 as a transitional step, with the temporary commitment to allow Tubos Reunidos to regain its equilibrium and restore its finantial stability, which was the purpose of the refinancing process concluded succesfully in December 2019. Mr. Gabiola has taken an active role in the process of his succession, and will continue adding value to the Company *via* his position as Director, being likewise designated after his appointment, which will be submitted to the General Shareholders Meeting for ratification, as Independent Coordinating Director, a figure that becomes necessary under the Spanish Law whenever the appointment of an Executive Chairman is made.

**Second.** The Company's Board of Directors, at its meeting held today, 28th of April 2019, with the prior favourable report and proposal made to that effect by the Appointments and Remunerations Committee, has resolved to **appoint Mr. Francisco Irazusta as Director and Executive Chairman of the Tubos Reunidos Group**, with Mr. Carlos López de las Heras mantaining his current functions and mission as General Manager of the Group, and working closely with the new Chairman.

In so doing, the Tubos Reunidos Group strengthens its top-level management, to properly lead the new stage started with the signing of the Refinancing Agrement, and to be able to face the demanding challenges that the Group will have to deal with in the years to come.

Mr. Francisco Irazusta was born in San Sebastian, and studied Science and Ceramic Engineering at the State University of New York (EEUU), obtained a Master of Science degree in Industrial Engineering by the Alfred University (EEUU) with postgraduates in Management and Finance by ESADE and CEU Business School. He began his professional career at the Quality and Production departments of the Kohler Group, and as Operations Director at the subsidiary of the Group Jacob Delafon España, being appointed as General Manager for Spain in 2000 and General Manager for Europe in 2003, based in Paris. In 2006 Mr. Irazusta joined the Anglo American Group, returning to Spain as General Manager of the Tarmac Iberia division, and leading the sale of the Group to Holcim España. In 2008 he joined Nutreco as General Manager and he leaded the adquisition and integration of Cargill Animal Nutrition into the Nanta Group. In 2011 he joined CRH as General Manager of the Building Products Europe division, based in Amsterdam.
