## Soltec Power Holdings announces the signing of a Liquidity Agreement

Pursuant to the provisions of Section 2 of Rule Four of Circular 1/2017, of 26 April, of the Spanish Securities and Exchange Commission on liquidity agreements, the Company announces that it has entered into a liquidity agreement (the "Liquidity Agreement") with the entity JB Capital Markets, Sociedad de Valores, S.A.U. (the "Financial Intermediary"), effective from January 14<sup>th</sup>, 2022.

For the purposes of the provisions of Subsection 2.a) of the aforementioned Rule Four, the following is hereby reported

(i) Stock which is the object of the Liquidity Agreement: Shares of Soltec Power Holdings, S.A., with ISIN ES0105513008.

(ii) Markets in which trading will take place: Trading will take place on the Madrid, Barcelona, Bilbao, and Valencia Stock Exchanges via the Stock Exchange Interconnection System (Continuous Market).

(iii) Term of the Liquidity Agreement: 12 months.

(iv) The summary of the operations carried out and the number of shares allocated to the securities account associated with the Liquidity Agreement in accordance with Annex I.

(v) The amount contributed for the acquisition of shares in the previous period was 514,690.11 euros. The amount allocated to the cash account associated with the beginning of the Liquidity Agreement is 530,757.92 euros.



It is hereby noted that the Liquidity Agreement complies with the agreement model included in Circular 1/2017.
